Atlantic Federal Credit Union 50/50 Raffle Rules

From September 2, 2019 to September 30, 2019 Atlantic Federal Credit Union branches, during regular business hours, will sell 50-50 raffle tickets to members and non-members, 18 years or older who live in Maine or New Hampshire. The cost for the 50-50 raffle tickets will be:

1 for \$1.00
5 for \$5.00
25 for \$10.00

Atlantic Federal Credit Union branches are located in Biddeford, Brunswick, Cumberland, Freeport, Saco, Sanford, Topsham and York, Maine. Exact addresses are available [here](#).

One winning name will be drawn at random on Tuesday October 1, 2019. The prize will be 50% of the total cash raised from September 2, 2019 to September 30, 2019. The minimum prize will be \$250. The Winner will be notified by phone. The prize will be awarded to the winner by October 31, 2019.

All funds raised will be sent to the *Take a Chance to End Hunger in Maine ("Take a Chance")*, 501(c)(3) not-for-profit public charity supported by the Maine Credit Union League. The Maine Credit Union league will present a check to the winner of the Atlantic federal Credit Union 50-50 raffle.

Atlantic Federal Credit Union will make a maximum of 3 (three) phone calls to the winner. The winner will have 45 (forty five) days to claim the prize. If the prize is not claimed within 45 days, then the prize will be forfeited. No other winner will be chosen. All funds will be donated to the *Take a Chance to End Hunger in Maine ("Take a Chance")*, 501(c)(3) not-for-profit public charity supported by the Maine Credit Union League.

If it is determined by Atlantic that a candidate is not eligible to receive a prize, another candidate may be selected and this process will continue until an eligible candidate is found. In the event that no candidates are found to meet the specifications the prize will go un-awarded.

Each announced winner is responsible for taxes and must complete and sign a Winner's Affidavit and Release, at an Atlantic branch, which confirms eligibility to receive the prize; permits use of name, contest entry materials, as defined in above; and releases Atlantic from all liability in connection with winner's participation in the contest and acceptance, use, or non-use of the prize.

All entrants and winners agree to give Atlantic Federal Credit Union unrestricted right to use, reuse, broadcast, or publish their name, city of residence, contest entry materials, photo, video tape, film or any other likeness for any reason Atlantic Federal Credit Union deems necessary without compensation, unless prohibited by law.
