2019 Amable A. Caron and Vivian Caron College Scholarship Application

Amable A. and Vivian Caron were long-time members of Atlantic Federal Credit Union who bequeathed funds to support continuing education. This scholarship will award five, \$500 scholarships. Recipients will be chosen, at random, from qualified applications.

Qualification requirements:

1. The college student applying for the scholarship **MUST HAVE** an open account with Atlantic of **which they are the primary account holder***.
2. The student must be or will be enrolled for spring a 2020, accredited, undergraduate or graduate program at a chosen college/vocational school, minimum 6 credit hours, per semester.
3. The student must complete the scholarship application.
4. The student must complete an essay** on this topic: **You are required to spend the next year of your life in either the past or the future. What year would you travel to and why?** (250 words minimum - 350 words maximum).

Application must be received or postmarked no later than December 9, 2019.

All applicants will be notified by mid-December. Scholarship recipients will be **awarded after the completion of their 2020 spring semester** in which the **student must maintain a 2.0 GPA (grade point average) or higher to be eligible.** See complete rules below.

Students awarded a scholarship will be responsible for providing Atlantic Federal Credit Union with all the documentation required after their spring semester is completed. **Scholarship payment will be DIRECTLY DEPOSITED into the student's account**, once documentation is received. Students that do not comply with all the requirements prior to October 16, 2020, will become ineligible for the scholarship.

Amable A. and Vivian Caron Scholarship Rules

The Amable A. and Vivian Caron 2019 Scholarship program is from October 28, 2019 to December 9, 2019 and is open to Atlantic Federal Credit Union members, **who are the primary account holder* of an open account**, and enrolled for a spring 2020, accredited, undergraduate or graduate program at a chosen college/vocational school, minimum 6 credit hours, per semester. Students must maintain a 2.0 GPA for the spring 2020 semester and then be registered for fall 2020 classes at an accredited, undergraduate or graduate program at a chosen college/vocational school, minimum 6 credit hours, per semester. Scholarship winners are responsible for submitting a request for payment and provide Atlantic with all documentation (grades and class schedule) required prior to award payment. A request for payment must be provided no later than October 16, 2020. If documentation is not received by October 16, 2020, then the scholarship award will be forfeited. Once reviewed and approved the scholarship payment will be directly deposited into the members account.

Members may download a scholarship application online or pick one up at any Atlantic branch: Biddeford, Brunswick, Cumberland, Freeport, Saco, Sanford, South Sanford, Topsham or York.

1. Applicants must complete the following essay: **You are required to spend the next year of your life in either the past or the future. What year would you travel to and why?** (250 words minimum - 350 words maximum).

All applications must be received or postmarked by December 9, 2019. Applications received after this date will be ineligible.
