2021 Amable A. Caron & Vivian Caron College Scholarship Application

Amable A. and Vivian Caron were long-time members of Atlantic Federal Credit Union who bequeathed funds to support continuing education. This scholarship will award one, \$2,500 scholarship. The recipient will be chosen, at random, from qualified applications.

Qualification requirements:

1. The college student applying for the scholarship **MUST HAVE** an open account with Atlantic, of **which they are the primary account holder***.
2. The student must be enrolled in a fall 2021, accredited, undergraduate, or graduate program at a chosen college/vocational school, minimum 6 credit hours, per semester.
3. The student must complete the scholarship application.
4. The student must complete an essay** on this topic: **Tell us about a personal achievement that makes you proud.** (250 words minimum - 350 words maximum).

Application must be received or postmarked no later than November 22, 2021.

Applicant will be notified by November 30. Scholarship recipient will be **awarded after the completion of their 2021 fall semester** in which the **student must maintain a 2.0 GPA (grade point average) or higher to be eligible and enrolled in spring 2022 classes.** See complete rules here: <https://www.atlanticfcu.com/about/scholarships.html>.

Student awarded a scholarship will be responsible for providing Atlantic Federal Credit Union with all the documentation required after their fall semester is completed. A request for payment must be provided no later than January 14, 2022. If documentation is not received by January 14, 2022, then the scholarship award will be forfeited. **Once reviewed and approved, the scholarship payment will be mailed to student's home address, and the check will be assigned to the school and student.**

2021 Amable A. Caron & Vivian Caron College Scholarship Rules

The 2021 Amable A. and Vivian Caron Scholarship program is from October 4, 2021, to November 22, 2021. Members may download the application online (www.atlanticfcu.com/about/scholarships.html) or may pick up an application at any Atlantic branch.

All applicants must meet the following qualifications to be considered for the \$2,500 scholarship:

5. The college student applying for the scholarship **MUST HAVE** an open account with Atlantic of **which they are the primary account holder***.
6. The student must be enrolled for fall 2021, accredited, undergraduate, or graduate program at a chosen college/vocational school, minimum 6 credit hours, per semester, and maintain a 2.0 GPA.
7. The student must complete the scholarship application.
8. The student must complete an essay on this topic: **Tell us about a personal achievement that makes you proud.** (250 words minimum - 350 words maximum).

Scholarship winner is responsible for submitting a request for payment to scholarship@atlanticfcu.com with required documents (**Fall 2021 grades and Spring 2022 schedule**) prior to award payment. A request for payment must be provided no later than January 14, 2022. If documentation is not received by January 14, 2022, then the scholarship award will be forfeited. Once reviewed and approved, the scholarship payment will be mailed to student's home address, and the check will be assigned to the school and student.

All applications must be received or postmarked by November 22, 2021. Applications received after this date will be ineligible.
