



Sea Dogs Contest Rules March 2nd, 2026

Atlantic Federal Credit Union Facebook Contests are solely sponsored by Atlantic Federal Credit Union. It is in no way sponsored, endorsed, or administered by, or associated with Facebook. Entrants are providing information to Atlantic Federal Credit Union and not Facebook.

From March 2nd, 2026, at 6:00 p.m. to March 5th, 2026, at 11:59 p.m., Atlantic Federal Credit Union will conduct a contest on social media and award four tickets to the Portland Sea Dogs game on Sunday, April 12th.

All entrants must be 18 years of age or older, Maine resident, and have not won an Atlantic contest in the past 60 days.

To enter for a chance to win (one entry per person), **individuals must go to the Atlantic Federal Credit Union Facebook page**, find the contest post that says *"Spring is right around the corner, and if you listen closely, you might just hear the crack of a baseball bat. Share your Sea Dogs pride by sending us a picture of you in your Sea Dogs merch or at a game!"* on March 2nd and comment with a picture within the comment section of the Sea Dogs Contest post. Up to thirteen people who has commented on the contest post between the contest dates will be randomly selected and, when deemed eligible, will be announced as the winner.

When the entrant's name is chosen at random, then that person, via email, shall sign a Winner's Affidavit and Release, which confirms eligibility to receive the prize, permits the use of the name, releases Atlantic from all liability in connection with the winner's participation in the contest and acceptance, use, or non-use of the prize and responsibility for taxes, if any. Their shared photo can be used in future Atlantic Sea Dogs marketing.

The announced winner will be contacted from the information they have provided by social media. The announced winner will have 24 hours with which to contact Atlantic and claim their prize. If the prize is not claimed in the allotted period, then another candidate may be selected, following the same method as described, and this process will continue until such time as an eligible candidate is found.

If it is determined by Atlantic that a candidate is not eligible to receive a prize, another candidate may be selected using the same process and will continue until such time as an eligible candidate is found. In the event that no candidates are found to meet the specifications, then the prize will go un-awarded. By participating in this contest, each participant agrees to waive any and all claims for damages for death, personal injury, and loss of property or property damage that he or she may sustain as a result of his or her participation in the contest and/or the use of any prize.
